

Invoice and refund policy for Tutor Training

1. General

1.1. This policy applies to all Sports Leaders UK qualifications, awards and services and replaces any previous versions. Where reference is made to invoicing or refund policy in any other document produced by Sports Leaders UK, and where any inconsistencies may occur, the information in this document takes precedence.

2. Review arrangements

- 2.1 We will review the policy as part of our self-evaluation arrangements and revise it as and when necessary in response to customer and learner feedback or requests from, or good practice guidance issued by, the regulatory authorities

3 Tutor training invoicing and payments

3.1 Invoicing and Terms

- 3.1.1 Sports Leaders UK will invoice your centre for products and/or services ordered or contracted to, in accordance with HMRC invoicing guidance.
- 3.1.2 At the point of applying for Tutor Training, centres must supply the booked delegate's contact details. Sports Leaders UK will invoice at this point the appropriate fee. Each invoice will display the ordered places, products and/or services and invoice value
- 3.1.3 Payment terms are 30 days from the invoice date. Failure to make a payment within this timescale may result in the withdrawal of credit facility and in the suspension or withdrawal of products and/or services ordered.
- 3.1.4 Sports Leaders UK reserves the right to vary payment terms at their discretion. This will be confirmed by Sports Leaders UK as required.

3.2 Payment for Services

- 3.2.1 The preferred method for receipt of monies is Bacs.
- 3.2.2 The following payment alternatives can be made available:
Cheque made payable to 'Sports Leaders UK'
- 3.2.3 Debit/credit card (any transactions over £500 will incur a 3% surcharge)
- 3.2.4 Sports Leaders UK require the customer to confirm payment with remittance advice to payments@sportsleaders.org

3.3 Credits and Refunds

- 3.3.1 For cancellations, the following terms will apply:

- 3.3.1.1 10 working days or more prior to the Tutor Training day – £25 admin fee will be charged.
 - 3.3.1.2 9 working days or less prior to the Tutor Training day – No refund given.
 - 3.3.2 Cancellations must be sent in writing to Sports Leaders UK, via email to ttcancellations@sportsleaders.org. A confirmation email will be sent within two working days. If you do not receive a cancellation confirmation within this timescale, you must contact us on 01908 689180 and go through to the Customer Services Team (Dial 1). Failure to do this will result in your cancellation not being processed.
 - 3.3.3 Where a credit is agreed, a credit note will be raised on your account for use against future courses, training or services. Refunds must be requested by email to payments@sportsleaders.org.
- 3.4 Transfers and changes
- 3.4.1 If the original Tutor Training day becomes inconvenient to attend, it is possible to rebook onto an alternative Tutor Training day, subject to the following conditions:
 - 3.4.1.1 Request must be emailed to contact@sportsleaders.org.
 - 3.4.1.2 For rebooking at least 10 working days notice in advance of the booked on Tutor Training course is required, a £25 transfer fee will apply.
 - 3.4.1.3 A rearranged Tutor Training course needs to take place within 6 months of the original Tutor Training day.
 - 3.4.1.4 Rebooking within 9 working days prior to the Tutor Training day is not possible. New booking will be required and no refund will be given for the original booking.
 - 3.4.1.5 Change of delegate's name is free of charge.
- 3.5 Bespoke Tutor Training Courses
- 3.5.1 Bespoke Tutor Training days will be invoiced in full at the time of booking. Agreed credit terms will apply.
 - 3.5.2 Should a Bespoke Tutor Training day be cancelled, a credit note will be raised for the original amount, less £500 to cover costs.
 - 3.5.3 Bespoke Tutor Training day cancelled within 9 working days of the Training day will not be eligible for a refund.
