

Sports Leaders UK Terms and Conditions to be a Centre for the Primary Leaders Licence

1.0 The Agreement

The agreement is between the British Sports Trust (trading as Sports Leaders UK) company number 04567192 and the Primary Leaders Centre. These Terms and Conditions once agreed enable a Centre to deliver the Sports Leaders UK Primary Leaders Offer.

2.0 Term

The agreement between Sports Leaders UK and the Centre shall start on the date the Centre agrees to these Terms and Conditions and shall continue in force until Sports Leaders UK terminates the agreement at the end of the Licence term (determined by the end of the academic year) or the Centre terminates the agreement.

3.0 Fees

3.1 Sports Leaders UK reserves the right to review the fees and shall inform Centres in writing of any changes.

3.2 The Centre understands that failure to pay Sports Leaders UK in accordance with the invoice and refund policy may result in services being suspended and/or Centre approval being terminated.

3.3 Every June Sports Leaders UK will invoice the Centre to renew the Primary Leaders Licence.

3.4 If the Centre is not planning to continue with the Primary Leaders Licence, they must inform Sports Leaders UK in writing in line with the [Invoicing and Refunds Policy](#).

4.0 How Sports Leaders UK communicates with the Centre

The Centre will:

4.1 Allow electronic communications regarding the management of the Centre and relevant Licence updates.

4.2 Be able to opt out of any marketing or promotional communications from Sports Leaders UK

5.0 Use of Sports Leaders UK branding and Intellectual Property

5.1 All rights (including ownership and copyright) in any specifications, instructions, Scheme of Work, plans, or other material furnished to or made available to the Centres by Sports Leaders UK shall remain vested solely as Sports Leaders UK's and the Centre shall not, without prior written consent of Sports Leaders UK, use or disclose to a third party.



The Centre will:

5.2 Not use the Sports Leaders UK logo or brand in a manner that dilutes its value, places Sports Leaders UK or its affiliates in a position of disrepute or causes confusion as to the relationship between the Centre and Sports Leaders UK. If Sports Leaders UK considers, in its sole discretion, that any of the Sports Leaders UK logos are being used in such a manner, the Centre, must immediately cease the use of the Sports Leaders UK logos in the particular manner upon request.

5.3 Acknowledge and agree that it has no right, title or interest in the Sports Leaders UK brand other than expressly by these terms and conditions, and that all such right, title or interest in the Sports Leaders UK logos shall be owned exclusively by Sports Leaders UK.

5.4 Acknowledge and agree that nothing in these terms and conditions shall be construed as an assignment or grant of any right, title or interest in or to the Sports Leaders UK logos or in any copyright or trade mark of Sports Leaders UK save for the limited right granted under these terms and conditions.

5.5 Accept that Sports Leaders UK and the officers, directors, employees or agents of any of them, exclude, to the maximum extent permitted by law, all liability and responsibility for any amount or kind of loss or damage that may result to you or a third party, (including without limitation, any direct, indirect, punitive or consequential loss or damages, or any loss of income, profits, goodwill, data, contracts, use of money, or loss or damages) arising from or connected in any way to the download and/or use, inability to download and/or use or the results of the download and/or use of the Sports Leaders UK logos. This shall not affect your statutory rights or any liability, damage or remedy that cannot be excluded under applicable law.

5.6 Accept that Sports Leaders UK reserves the right to request you to immediately stop any use of the Sports Leaders UK logos if you fail to comply with any of these Terms and Conditions or for any other reason. Upon such request, you shall immediately stop your use of the Sports Leaders UK logos and immediately destroy all non-published copies of the Sports Leaders UK logos.

6.0 General

The Centre will:

6.1 Ensure that each establishment the Licence is purchased for has insurance cover for a minimum of £5 million against public liability or similar liability arising from activities as a Centre.

6.2 Accept that agreement with these Terms and Conditions forms a contract between the Centre and Sports Leaders UK and the terms specified in this agreement will be referred to where there is any dispute or disagreement relating to the role and responsibilities of the Centre.

6.3 Ensure that a Licence is purchased for each primary school where the Primary Leader Licence is delivered.

7.0 Declaration

The Centre hereby warrants and undertakes to Sports Leaders UK that:



- 7.1 It is free to enter into this agreement and is not bound by, and not aware of, any circumstances which would prevent the Centre from complying with the Terms and Conditions.
- 7.2 All information supplied by the Centre is genuine and correct.
- 7.3 It shall perform its obligations under this agreement with due care, skill and diligence and ensure its personnel shall have the necessary professional capabilities, qualifications and experience, skills and expertise required.
